THIS WEEK'S NEW BUSINESS

 - Satanic Virginia is experiencing challenges with their IRS 501c3 application, they currently have been told to resubmit the application and the (very expensive) fee.
 - Senators shared ideas for a possible amendment to the Senate Procedures and Policies, to allow absentee voting because the Senate has failed to meet quorum for a vote on many occasions.
 - Allowing absentee voting if quorum can't be reached, to allow voting on urgent matters
 - Time limit on voting potentially a week or two after the meeting where the vote was supposed to take place.

- In addition to protest safety, Senators shared protective measures individual congregations are taking to secure safety in their spaces
 - Senator from Satanic Virginia mentioned adding a requirement for blasphemy in their social media group questions. Often, requiring applicants to "Deny the Holy Spirit" weeds out Christians who are trying to proselytize.
 - o Discussion about membership process for individual congregations
 - membership applications, interviews, check social media posts of people asking to participate, background checks for congregants.
