• Clarify affiliate groups and related concepts

- In the volunteers meeting everyone had different ideas about what "affiliate groups" meant
- Non-regional group that provides services or activities
 - Book clubs
 - Religious services
 - Writer's group
 - Online groups without a regional boundary
 - **...**?
- We don't want this to be a "my congregation is interested but unsure, just dipping a toe in" kind of thing
 - We want to push congregations toward full membership
- Maybe add another layer to congregation status: You ARE a congregation or working toward being a congregation. Those working toward becoming a congregation would not be an affiliate group, they would just have no "power" (think candidate group, old org).
 - Time-limited (ex: 1 year and then you must be ready to go)
 - What can we provide that would encourage them to go to the next level?
 - They have access to our organizing docs
 - They do not have representation on the board or senate
 - Would we add them to our site as an upcoming congregation? Mabe as "Baby Goat Congregations" to differentiate.
 - Potential names for these groups:
 - Baby Goat Congregations
 - o ...?

- What can we do to get the word out about CSC? feedback from volunteers
 - Work to get volunteers involved so lots of people are able to talk about CSC
 - A FAQ to post on social media or the website—record a short Q&A to throw onto sites
 - We do have a FAQ on the website as of right now
 - "Fireside chats" for community building
 - Put out a call for submissions of questions and what people want to know
 - Maybe start with questions from our volunteer group? Or maybe put it out to the public to get more people involved and interested since volunteers are already on board.
 - o Record videos about "What Satanism means" to the founders
 - Short videos from volunteers about why they're excited about CSC
 - Write bios of the founders
 - We want to seem approachable!
