RECURRING BUSINESS

- **Member Congregation Updates - update tracker doc**
 - Mo is meeting with the senator from [redacted] tomorrow night
 - Mo reached out to [redacted] and is waiting to hear back
- **Potential Congregation updates**
 - The congregation leader for Satanic Virginia spoke with Mo about [redacted organization] applying as a congregation
 - Mo reached out to them about potentially joining CSC
 - They're not specifically Satanic, but we could potentially "ally" with them
- **Volunteers updates**
 - Two of the new volunteers Mo is onboarding still need to submit the last of their paperwork
 - Action item: Mo will get the volunteers on our volunteer discord once they're official
 - Zora is working with [redacted] and [redacted] to onboard them

- **501c3 application**
 - Our application revisions were submitted this week. We're currently waiting to hear back
- **Someone volunteered to run a virtual D&D campaign for the coalition**
 - First meeting is scheduled for February 21st
- **Board member first terms have ended**
 - Action item: Kate will draft updates to the board processes (carried over from last week)
 - Action item: Kate will reach out to Mo to schedule a meeting to work on this together, and Kate will invite the rest of the Board once a date/time is picked
- **Senate support**
 - Mo is ready to focus on this again
 - Mo will talk to [redacted] about it at the Senate meeting this evening
- **Fundraising - Hellathon event**
