UPDATES TO OLD BUSINESS

- **KoS has a new Senator**

- **Offboarding**

 - Action item: Mo will ask Harry for help with this
 - We need to offboard KoS's old Senator once we have the new Senator's paperwork
 - Action item: Mo is still working on changing the social media passwords
 - Zora talked to Harry and got most of the document ownership transferred
 - Action item: Zora will follow up with Harry about transferring the last couple documents
- **Ethics Committee**
 - Zora reached out to someone she thinks would be great for this committee. They're interested!

- **501c3 application:**
 - Mo and Kate will meet on Wednesday
- **Fundraising**
 - No updates this week
- **Clergy Committee**
 - Mo met with [redacted for privacy] about making the initial scope smaller so we can get it off the ground
 - Action item: Mo will rewrite the charter
 - [redacted for privacy] is working on 3-5 lessons to get us started
- **Creating next committees**
 - Action item: Mo plans to have charters drafted for both the clergy committee and services committee by August 3rd
- **Sharing resources between congregations**
 - Isaac talked to their congregation's secretary to gather useful documents

 - Mo got copies of Harry's books to upload
 - Action item: Sarah will work on making the resources we have so far available
 - Action item: Sarah will make a separate doc linking to the resources so it's organized and easy to navigate
 - Action item: Isaac will talk to Mo about Baby Goat Group ideas
- **Sarah is working on plans for a worksheet for helping people handle trauma from the old org**
 - Sarah isn't here this week

- Action item: Zora will talk to Sarah about getting access to the intro/main document so she can review it and add ideas
- **We need one more board member**
