UPDATES TO OLD BUSINESS

- **KoS has a new Senator**
 - We're still waiting to hear back with their paperwork
 - Action item: Mo will work with [redacted for privacy] to move this forward

 - Kate didn't make any progress here this week but she did realize we'll have to put only the PDF versions in the public folder, so the redaction history isn't visible
 - Action item: Kate will try switching this over so it's a link to the "published" minutes folder, which will be visible publicly (carried over from last week)
- **Trello Board**
 - Action item: Mo will do a pass at setting this up
- **Drive permissions discussion**
 - Mo accepted a whole bunch of doc ownership transfers. You can do these in bulk which makes it a lot easier
- **Offboarding**
 - Action item: Mo will offboard the old KoS Senator once the new one is in
 - We're still waiting on the new Senator's paperwork
 - Action item: Mo will look into how the .org email addresses are working and show us how to access them
 - Action item: Mo will take a look and see if we can change the passwords on the social media accounts without Harry
 - Action item: Zora will send Mo a list of the passwords that didn't get updated
 - Action item: Zora will meet with Harry to transfer the last of his documents
- **Ethics Committee**

 - We might have more success reaching out to people we'd like to see on this committee directly
 - Action item: Zora has an idea - she'll reach out to them
- **501c3 application:**

 - Action item: Mo will work on getting together funds for this application - we don't want to have to wait until we've done a fundraiser
