### RECURRING BUSINESS

- **Member Congregation Updates - update tracker doc**
  - No updates this week
- **Potential Congregation updates**

- **Services**
  - Zora will lead services on Friday the 20th, with the topic “recent legislative wins”
    - Sarah won’t be there - she has important plans
  - We can use Mo and Sarah’s invocation recording to kick off our next services
- **Review Senate meeting minutes**
  - Action item: Asmodeus Sion will talk to the Senate Secretary about including a list of which members were absent
  - Action item: Mo will also talk to AASC’s Senator about promoting AASC’s event, and recommend asking for pet photos and recipes in the Pandemonium discord

### THIS WEEK’S NEW BUSINESS

- **KoS has a new Senator**
  - The new Senator has been sent their paperwork
  - Action item: Once the paperwork is back, Mo will talk to the Ethics Committee about a background check and finish the onboarding process

## UPDATES TO OLD BUSINESS

- **The meeting minutes on the website don't show the full history**
  - Kate didn't make any progress here this week
  - Action item: Kate will try switching this over so it's a link to the "published" minutes folder, which will be visible publicly (carried over from last week)
- **Trello Board**
  - Mo made a Trello board and invited the rest of the board
    - Action item: Mo will do a pass at setting it up
- **Drive permissions discussion**
  - Sarah, Mo, and Zora did a bunch of transferring document ownership to the CSC account
    - Action item: Kate still needs to do a pass
  - [some document permission discussion redacted for security]
- **Offboarding**
  - Action item: Mo will offboard the old KoS senator once the new one is in
  - Zora tried to simplify the process doc, but decided it actually needs to be that complex
  - We have everyone's email addresses in the Pandemonium application form spreadsheet
  - Action item: Mo and Zora will meet on Wednesday to review the doc encryption process
  - [some password discussion redacted for security]
- **We need one more board member**
  - Florida's Senator is going to join the board! He announced it at the last Senate meeting
    - They are working on setting up a new Senator for their congregation
- **Ethics Committee**
  - Mo talked to [Ethics Committee Leader] about how we'll need to do a new background check soon for KoS's new senator
- **501c3 application:**
  - Action item: Kate will review Mo's notes and then schedule a meeting with him (carried over from last week)
- **Clergy Committee**
  - Action item: Mo will chat with [Clergy Committee Leader] about Clergy Committee stuff
  - [redacted] might be interested in co-leading this committee
- **Sharing resources between congregations**
  - Action item: Sarah will do some organizing, set the visibility on the documents, and announce it
    - Action item: Mo and Zora will review the docs and suggest anything that would be useful to add

- We'll plan to reconvene about this in about a month
  - When they're ready, Kate and Mo will share the 501c3 application docs as a resource
- **Creating next committees**
  - Action item: Mo will draft a Services Committee charter in the next couple weeks
- **Fundraising**
  - Mo's congregation had some ideas for a Hellathon fundraiser to cover the 501c3 application fee
- **Sarah is working on plans for a support group for helping people handle trauma from the old org**
  - Sarah is still working on this
  - She's thinking about making it a self-directed course folks can walk through whenever
